### Awards highlight commitment to customers, community

Looking back, 2007 has been a year of change and growth. One thing hasn't changed, however—the work that we do every day and all year to benefit our customers is interconnected and continues to be noticed.

Back in February, EID received the *Golden Orb* from PG&E in recognition of the previous year's "outstanding achievement" in our demand reduction programs. By reducing our energy demand during peak-use periods, we help to reduce the chance of brownouts or other interruptions, and we save on our electric bill.

Our demand reduction programs were honored again in mid-November, when EID received an award for "vision and leadership in raising the awareness and urgency of climate change" during the California Water Policy 17 Conference. This award recognizes our ongoing energy efficiency initiative that includes the demand reduction program and other high-profile programs and projects—such as drought preparedness and solar power generation—to reduce both the consumption and cost of energy across the District.

### **Employee honors benefit the District**

Elizabeth Wells, co-manager for engineering in the wastewater/recycled water division, has been nominated to serve on the board of trustees of the California Section of the national WaterReuse Association. Her two-year term begins in April. The California Section's focus is to promote responsible stewardship of California's water resources through safe, practical, and beneficial use of recycled water.

And **Dana Strahan**, co-manager for operations in the drinking water division, was invited to serve on the California Department of Public Health's Grade T5 Water Treatment Operator Certification Panel. T-5 is the most advanced certification for drinking water treatment operators, and the panel that administers the exam includes experts like Dana from across the state.

These honors reaffirm the dedication Elizabeth and Dana bring to their work. And they ensure that EID will be well represented in two important industry arenas.
