**FOOTNOTES:**

- [1] This is the Single Family Residential (SFR) base charge less the Single Family Dual Plumbed Residential base charge shown under Recycled Water Rates.  
 [2] The base charge for Raw Water metered landscape irrigation is shown in the Water Rates Agricultural Irrigation without residence and Raw metered section.  
 [3] This rate is the SFR base charge, plus the SFR average use of 1,600 cf billed at the Single Family Residential commodity charge.  
 [4] This rate is the Commercial - Low (COMLOW) base charge, plus the COMLOW average use of 3,780 cf billed at the COMLOW commodity charge.
