The El Dorado Irrigation District is the owner and operator of the Deer Creek Wastewater Treatment Plant (Facility), a publically owned treatment works located at 1565 Deer Creek Road, Cameron Park, California. The Facility serves a population of 20,000 within the service areas of Cameron Park, Shingle Springs, and Mother Lode. The Facility has the design capacity to treat 3.6 million gallons per day. Discharges from the Facility are currently regulated by Waste Discharge Requirements (WDRs) Order R5-2014-0081 and Time Schedule Order (TSO) R5-2013-0901.

The Discharger has completed a zinc water effects ratio (WER) study; therefore, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) proposes to rescind TSO R5-2013-0901 and amend WDRs Order R5-2014-0081 (NPDES No. CA0078662) to 1) establish a site-specific WER of 1.7 for total recoverable and dissolved zinc, 2) remove effluent limitations for zinc, and 3) remove monthly effluent monitoring requirements for zinc.
