NOTICE OF INTENT
TO ADOPT A MITIGATED NEGATIVE DECLARATION
(Pursuant to CEQA Section 21092 and CEQA Guidelines Section 15072)

AND

NOTICE OF PUBLIC HEARING
TOWN CENTER FORCE MAIN REPLACEMENT PHASE 2 PROJECT

El Dorado Irrigation District (EID) proposes to adopt a Mitigated Negative Declaration pursuant to the California Environmental Quality Act (Section 15000 et seq., Title 14, California Code of Regulations) for the Town Center Force Main Replacement Phase 2 Project (Project). The Project site is located in Placerville in El Dorado Road and Mother Lode Drive in El Dorado County. The Project is located within Section 22 of Township 10 North, Range 10 East, Mount Diablo Baseline & Meridian on the United States Geological Survey (USGS) Placerville 7.5 Minute Quadrangle map.

The El Dorado Irrigation District (District) plans to install 12,885 feet of new 10-inch force main in El Dorado Road and Mother Lode Drive. The existing force main pipeline consists of approximately 12,885 feet of 8-inch asbestos cement (AC) pipe and 1,208 feet of ten inch polyvinyl chloride (PVC) pipe.

EID is the lead agency under the California Environmental Quality Act for the Project. Members of the public are invited to comment on the proposed Mitigated Negative Declaration. The comment period is from June 28, 2017 to July 28, 2017. The proposed Mitigated Negative Declaration and Initial Study can be reviewed at EID's Customer Service Building, 2890 Mosquito Road, Placerville, CA 95667 or on the EID web site at www.eid.org. EID will hold a public hearing to consider the Mitigated Negative Declaration on August 14, 2017 at 9:00 a.m. during a regularly scheduled meeting of the EID Board of Directors. The hearing will be held in the EID Customer Service Building at the above address.

Comments on the Mitigated Negative Declaration must be received by 5:00 p.m. on July 28, 2017.
