DEER MORTALITY RECORDS FOR EL DORADO CANAL 1983-1998

In order to assess the condition and efficacy of wildlife fences, crossings, and escape structures associated with the El Dorado canal the Forest Service requested a review of historic data on wildlife mortality associated with the canal and the efficacy of existing wildlife escape structures in preventing mortality (page 50, *Forest Service Response to Initial Stage Consultation Package*, 22, September 1998).

The following table documents the deer mortality records for the El Dorado Canal for the years between 1983-1998. Data was obtained from two locations on the canal, Camp 1 (Siphon Alder Creek) and Camp 2 (Plum Creek). A total of 71 dead deer from Camp 1 and 36 dead deer from Camp 2 were found in the canal during the fifteen year period. Dead deer were found at both locations during the years 1984-1992. There were no dead deer found at Camp 2 for the years 1993-1998. There were no dead deer found at Camp 1 for the years 1993-1995 and 1997. It is unclear why deer mortality records differ from year to year.
